**Terms and condition.**

1. The tender document can be obtained from the office of the Gangtok Municipal Corporation on payment of Rs 1000/ (Rupees one thousand) at the Axis Bank extension counter at Gangtok Municipal Corporation office during working hours.
2. The tender document should be duly accompanied by original temporary deposit of 10% i.e Rs.3,965 (Rupees. Three thousand nine hundred sixty five only.) of the Government Salvage valuation of the vehicle drawn in favor of Municipal Finance Officer of Gangtok Municipal Corporation from the Axis Bank counter of Gangtok Municipal Corporation office and should reach on or before 08.09.2018 within 3:00 Pm in the Office of the Municipal Commissioner Gangtok Municipal Corporation, Deorali and the same will be opened on 10.09.2018 at 2:30 PM.
3. The tender form should be accompanied with the original temporary deposit challan failing which the tender will be rejected
4. The highest successful bidder will have to deposit the quoted amount within 7 (seven) days from the date of allotment order and failing which his/her temporary deposit shall be forfeited without any prior notice and the vehicle shall be allotted to the next highest bidder. If the next highest bidder also fails to lift the vehicle within 7 (seven) days from the award of the lifting order re-tender for the same will be initiated. The temporary deposit of the unsuccessful bidder shall be refunded only after the finalization of the auction.
